REGISTRATION INSTRUCTIONS

- One Registration Form is needed per adult. Ask the participant to complete the personal information, requesting that they print clearly.
- When family members participate together, then one adult (either parent or guardian) adds the children (under the age of 18) to their form.
- If there is a Registration Fee, make it clear to the participant before they complete the form. Once Registration Fee is paid by the participant, initial/sign where indicated on form to indicate this fee payment has been received. This money is to be kept separate from donations/pledges. The grandmothers group shall use the registration fee to pay for costs associated with the walk. It is up to the grandmothers group to decide what to do with any remaining funds. **Note that a tax receipt cannot be given to walk participants for the registration fee.**
- It is very important that each participant signs the Registration Form, as it serves as a waiver that protects the organizers and volunteers of the National Walk, in case of an accident. If someone refuses to sign the waiver, they will not be able to participate.
- Ask the participant to review and sign the Permission to Photograph. Make photographer aware of any participant who refuses to sign so that their (or child's) picture will not be taken.
